



STATUTE OF SPINAL CORD INJURY NETWORK NEPAL 2075

PREAMBLE: -

Whereas Spinal Cord Injury Network Nepal has been established with the main objective of providing free treatment and rehabilitation to people with spinal cord injury, loss of consciousness or movement in their arms or legs, as well as other vital organs, due to injuries or diseases caused by the devastating earthquake of 2072 B.S, ten years of armed conflict and various other causes, creating awareness in the society, providing skills or vocational education based on their interests, qualifications and abilities, creating employment or self-employment, developing their physical, mental, social and economic aspects, healing them from stress or depression, making them energetic and self-reliant, coordinating with the Government of Nepal to formulate policies and rules, and taking initiatives and advocacy for ensuring their rights, collaborating with various organizations and donor agencies for development, as well as identifying such people in the national and international communities without discrimination and providing all possible support for their independent and harmonious living. This statute has been formulated under the Registration Act 2034 B.S.

Chapter-1

Preliminary

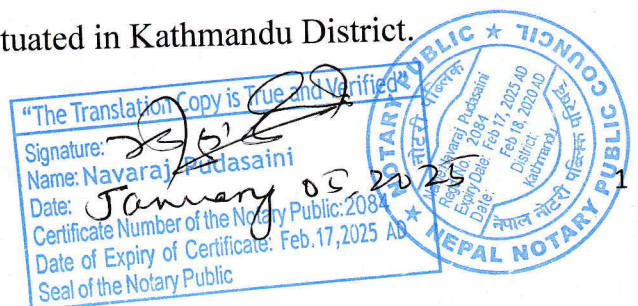
1. Name of the Organization

The name of the Organization shall be titled Spinal Cord Injury Network Nepal. It shall be abbreviated as SCIN Nepal.

a. Address Where the Organization's Office will be situated

The main office of the Organization shall be situated in Kathmandu District.

b. The Working Area of the Office





The program shall be conducted upon necessity by getting a prior approval from the concerned local authority of a district.

c. Commencement

This statute shall come into force from the day the organization is registered.

d. Status of the organization

The organization shall be autonomous and corporate with perpetual succession, non-profit making and non-governmental organization. The organization, except for attaining the objective of the organization, shall not perform any consultation services with or without taking fee.

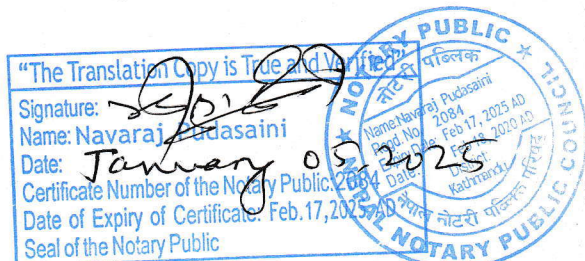
2. Definitions

Unless the subject or the context otherwise requires, in this statute:

- a) "Statute" means the Statute of Spinal Cord Injury Network Nepal-2015.
- b) "Organization" refers to Spinal Cord Injury Network Nepal.
- c) "Committee" means the Executive Committee formed duly as per section 13 of the statute.
- d) "Assembly" means the Annual General Assembly which shall refer to a Special General Assembly to be held in a special circumstance.
- e) "Officials" means Committees' Members of the Organization.
- f) "Rules" means the rules and byelaws to be framed under the statute.
- g) "Local Authority" means concerned Chief District Officer.
- h) "Prescribed "or "As Prescribed" means prescribed or as prescribed in this statute and other rules made under this statute.
- i) "Local Level" means Rural Municipality, Sub- Metropolitan city/ Metropolitan city /Municipality and District Coordination Committee.

3. Stamp and Logo of the Organization

The Organization shall have a separate stamp and a logo. It shall be as prescribed in schedule-1 and 2. In case, the name, stamp and logo of the organization concur with any other organization before the formal registration, it shall be amended immediately with due procedures.





Chapter-2

Objectives

4. Objectives of the organization

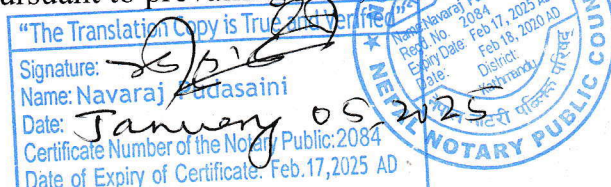
The objectives of Organization are as follows:

- A) To collect data on people with spinal cord injuries who are scattered or living in dark rooms within Nepal and take necessary initiatives to arrange for employment and professional activities according to their interests, abilities, and qualifications, including joint residential areas.
- B) Through the Government of Nepal, initiatives shall be taken to identify and protect the lives of people with spinal cord injury by providing special relief to them on priority in all kinds of government opportunities, such as education, health, sports, employment and transportation, especially in rehabilitation.
- C) To work or caused to be worked in collaboration with the Government of Nepal, associations, institutions and individuals in the construction of accessible infrastructure.
- D) To take the initiative to publish reference materials that make knowledge about spinal cord injury mandatory from the lower secondary level of the government curriculum.
- E) To act as a judicial institution on the rights of persons with disabilities and to implement the UNCRPD on their behalf, and to enter into agreements and coordination with national, international governmental or non-governmental organizations to conduct various awareness raising and employment generating programs.
- F) To attain the above-mentioned objectives, it will be done only with the prior approval of the concerned body if it has to be approved in advance by the concerned body.

5. Functions that may be performed for attainment of the objectives of the organization:

The organization shall perform following functions to attain the objectives;

- A) The organization shall implement the objectives to be implemented only after obtaining approval or license pursuant to prevailing laws, wherever necessary.





- B) Micro, small and medium-sized enterprises and businesses that suit people with this type of disability shall be operated and made them self-sufficient.
- C) Seminars, orientation, training, recreational, cultural programs and growth testing competitions shall be conducted with the active participation of persons with spinal cord injury.
- D) The organization shall conduct such programs not affecting the programs of other registered organizations while achieving its goals.
- E) The organization shall use all the necessary things like building, construction of training building, renting or leasing and buying or renting office equipment and vehicles like computer, telephone, fax, photocopy machine.
- F) This organization shall appoint the necessary staff and determine their terms of service.
- G) It shall work in coordination with various national and international non-governmental organizations with similar objectives.
- H) Members affiliated to the organization can participate in disability-related programs or competitions organized by any national, international organization with the recommendation of the organization.

Chapter-3

Membership

6. Classification of Membership

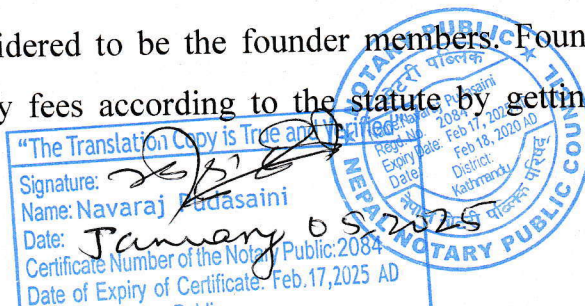
The Organization shall have four types of members classified as follows:

A) General Member

Any Nepali Citizen having had the qualifications according to the section 7 of this statute applies for its membership under the prescribed procedure, the persons with spinal cord injury who have got the membership of the organization shall be of ordinary members.

B) Founder Member

The officials who signed in this Statute at the time of incorporation of the organization shall be considered to be the founder members. Founding members shall have to pay fees according to the statute by getting its





ordinary and life membership. Founding members can vote at the organization's convention.

C) Life Member

Life membership shall be granted to those who have made special contribution for the development of the organization under the prescribed procedure. Founding members shall automatically become life members. The members who have received the life membership of the organization shall become its voters.

D) Honorary Member

Honorary members of the organization may be granted to notable social workers and distinguished Nepalese citizens as deemed appropriate by the decision of the general assembly, however the honorary members will not have voting rights.

7. Necessary Qualifications for obtaining the Membership

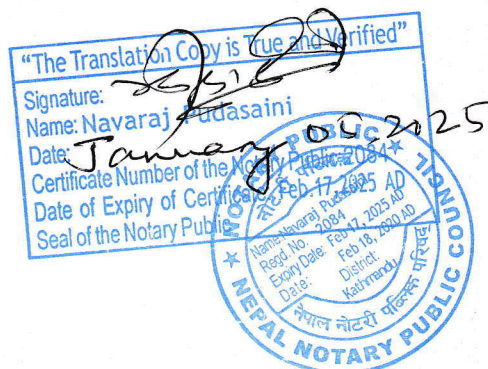
Following are the criterions to receive the membership of this organization:

- A. The person must be a Nepali citizen.
- B. Having attained the age of 18 years
- C. Not lost of mental balance.
- D. He/she must be found not guilty of misuse of public funds.
- E. Having not convicted and punished on the charges of embezzlement of public property and corruption.
- F. Person having a suspected spinal injury.
- G. In addition to the matters mentioned above, any citizen who is willing to accept the objectives of the organization by giving special assistance to this organization can become a member subject to the statute of the organization.

8. Disqualification or mode of not holding the membership

None of the person may obtain or be granted the membership of the organization on the following conditions:

- a) Non-Nepali citizen.
- b) Having not attained 18 years of age.
- c) Having lost of or bad mental balance.





- d) Found guilty of misuse of public property.
- e) Found guilty of any of the criminal charged and corruption from the court
- f) Having not acquired the Nepalese citizenship.
- g) Having had personal interest towards the operation of the organization.
- h) Having fallen in insolvency.
- i) Any person who was convicted by the court and was accused of being involved in any type of theft, robbery, forgery or misuse of possessing assets illegally or charged him with corruption by the court and not completed a year jail term.
- j) If the working committee proves an abuse committed against any person.

9. Termination of the membership

No person shall be a member of the organization in the following conditions.:

- a) In case of not being able to obtain the membership as per section 8 of this statute.
 - b) If s/he submits her/his resignation and gets it approved,
 - c) In case the illicit motive of misconduct in the activities of the organization has been proved by the Court.
 - d) If the membership fee remains to be paid
 - e) If the majority of 75 percent of the general members pass the resolution to remove the member from the position of the organization.
 - f) In case of undertaking any act which is not prescribed to be done according to this statute.
 - g) In case of dissolution of the organization
- 2) Provided that prior to declaring one ineligible for membership or remaining in the organization, the organization shall give a prior notice and provide reasonable time to furnish clarification to prove him/her eligible.

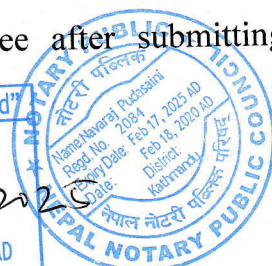
10. Membership fee and Mode of granting membership

The members pursuant to the section 6 of this statute, shall receive the membership upon payment of a specified membership fee in following sub-sections.

1) General Member

A person desirous of obtaining ordinary membership shall be entitled to get the membership on the decision of the Working Committee after submitting an

application in accordance with the prescribed procedure by paying an entry fee of Rs.500 and an annual fee of Rs.100

Members are required to pay an annual renewal fee of Rs 100.

A member who receives ordinary membership should get its membership renewed within end of the month of Chaitra every year and thereafter may get it renewed upon payment of an additional charges as prescribed. Otherwise, the general membership may be cancelled

2) Founder Member:

- a) The officials of the *Ad hoc* Committee at the time of incorporation of this organization shall be the founder members. Since founding members are automatically the life members, such members do not have to pay fees.

3) Life Member

The decision of the Executive Committee can grant lifetime membership to those who apply under the prescribed procedure by paying a lump sum of Rs. 2,500 to the organization.

4) Honorary Member

Pursuant to the decision of the general assembly, honorary membership can be granted to social workers, distinguished persons and distinguished Nepali citizens and foreign dignitaries, but honorary members will have no voting rights.

- 5) If a decision is made not to grant membership to an applicant, the applicant will be informed of the reason.
- 6) All members must comply with the provisions of this statute and the rules and regulations made under the statute.
- 7) There shall be a separate record book for the members in the prescribed format pursuant to the sub-sections 1, 2, 3 and 4 conferred by the organization.

Chapter-4

Provisions related to General Assembly, Executive Committee and Meetings

11. Formation of the General Assembly

1. The general assembly of the Organization shall be formed from amongst the members who have obtained membership pursuant to the section 7 of this statute

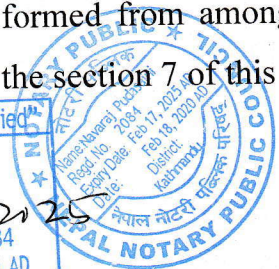

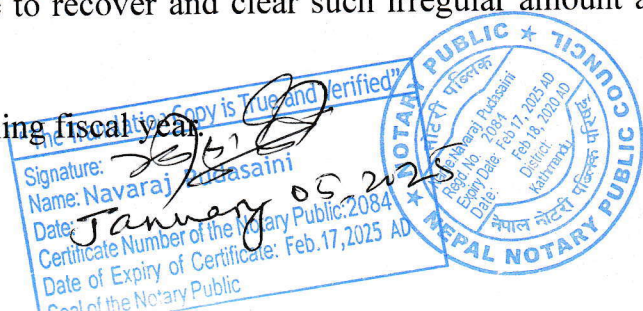
other than the honorary members. The honorary members shall be invitees. The general assembly shall be of its supreme body.

2. The general assembly of the Organization shall be as follows;
 - a. Annual general assembly: the general assembly shall be held once a year.
 - b. Special General Assembly: if one fourth of the total members of the organization made a submission, with due reasons, for holding the special general assembly, the Executive Committee shall compulsorily convene the special general meeting compulsorily within 30 days. Provided that the special general assembly cannot be held again within six months from the time of holding the general assembly or special general assembly.
3. The first annual general assembly of this organization shall be held within two months from the formal registration of the organization. And the consecutive general assembly shall be held within two months from the completion of the fiscal year.
4. Every general member shall be given notice indicating the venue, date, time and agenda of the assembly in advance of at least 15 days to hold the annual assembly of this organization and at least 7 days in advance to hold the special general assembly.
5. If the general assembly that was called according to the sub-section 4, could not be held due to the want to a quorum under section 18, the next general assembly meeting shall be re-convened by giving a time-limit of at least 7 days' notice.
6. Separate minute books shall be maintained for the general assembly and special general assembly.

12. Functions, Duties and Powers of the General Assembly

The functions, duties and powers of the general assembly shall be as follows:

- 1) To accept the plans, programs and annual budget presented by the Executive Committee.
- 2) To discuss and endorse the annual audit report submitted by the auditor and hold and direct the Executive Committee to recover and clear such irregular amount as cannot be regularized.
- 3) To appoint the auditor for the upcoming fiscal year.





- 4) To evaluate the annual progress report and activities carried out by the organization and gave necessary direction to the Executive Committee.
- 5) To conduct election of the Executive Committee following the completion of tenure of the Officials.
- 6) To amend the statute; approve the rules and regulations, and other agendas submitted by the Executive Committee.
- 7) To review and approve the activities and actions submitted by the Executive Committee.
- 8) To confer honorary membership.
- 9) To approve the work and actions that are in the interest of the organization by the working committee after considering the justification
- 10) To provide approval as required for the recruitment, allowances and other facilities of the employees submitted by the working committee to be borne from the organization's own internal resources.

13. Formation of the Executive Committee

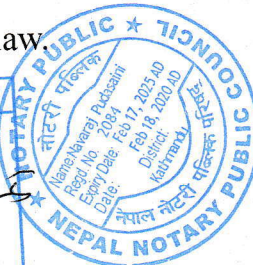
1. A 7-member working committee shall be formed, consisting of the following office bearers elected from amongst the members of the general assembly.

Chair Person	1
Vice-Chair Person	1
Secretary	1
Treasurer	1
Members	3
Total members	7

2. The tenure of the Executive Committee shall be of 2 years.
3. In case the position of any member falls vacant prior to holding of the general assembly, the Executive Committee may appoint another member for the remaining term. A member appointed to fill any mid-term vacancy in the post of member shall remain in office only for the remaining term of his/her predecessor. However, for other posts, the posts will be filled through the election process for the remaining period as per the law.

4. The meeting of the Executive Committee shall be called by the secretary as instructed by the chairperson. Provided that where 51% of the total numbers of members make a submission for the meeting of the Executive Committee, the Chairperson shall instruct the secretary to call the meeting.
5. No meeting of the working committee shall be hold unless 51% of its total members are present.
6. The Chairman of the Executive Committee shall preside over the meeting, but in his/her absence the vice chairman shall preside over the meeting. In case the vice-chairman is also absent, the most senior person or a person nominated by the members from among themselves shall preside over the meeting.
7. The majority in the meeting of the Executive Committee shall be the final decision, and if the votes are equal or tied, the chairperson may exercise a decisive vote.
8. The agendas of the meeting being discussed shall be kept in separate minutes and all the members present in the meeting shall have to sign in the details of the decision, but those who disagree with the decision shall have to sign in the minutes mentioning their note of dissent.
9. All the activities of the organization that are expected to be done shall be approved by the Executive Committee.
10. Notwithstanding anything contained in the above stated clauses, if all the officials of the Executive Committee agree in writing on any matter that it may carry out, the matters may be performed even without holding a meeting by enclosing such agreement in the minute book. Such agreement shall be deemed to be a decision of the meeting of the Executive Committee.

14. Functions, Duties and Powers of the Executive Committee

The functions, duties and powers of the Executive Committee shall be as follows;

- a. To prepare the annual program and estimated budget of the organization for the next year and present it in the general meeting
- b. To enforce the decisions of the General Assembly by following the provisions of the Statute.
- c. To conduct programs in the interest of the organization





- d. To be accountable to the General Assembly.
- e. To have optimum use of the means of resources as available for the attainment of the objectives of the organization.
- f. To make action plans, collect resources, and implement, supervise and monitor the work of the organization
- g. To keep funds and assets of the organization in a safe manner and open and operate bank accounts.
- h. To prepare the staff regulations regarding the service conditions and facilities of the employees of the organization and get them approved by the general assembly and implemented or cause to be implemented.
- i. To form an advisory committee and other sub-committees of suitable people during their working period and distribute the work according to the need in order to fulfil the objectives of the organization.
- j. To perform the leadership role of the organization.

15. Cessation of office-bearers of Executive Committee

The chairman may submit resignation to the Executive Committee through the vice-chairman and other portfolios including vice-chairman may submit resignation before the chairman.

16. Other committees

1. The Executive Committee, as per need, may form other committees and sub-committees to undertake activities of the organization subject to the statute but it needs to be approved by the general assembly meeting.
2. The functions of the sub-committees shall be as prescribed by the Executive Committee.

Chapter-5

17. Functions, Duties and Powers of the Executive Committee's Members

The Functions, duties and powers of the Executive Committee's members shall be as follows;

1. Functions, Duties and Powers of the Chairperson

- a) Preside over committee and assembly meetings, conduct meetings

- b) cast the deciding vote
- c) Representing or appointing a representative on behalf of the organization
- d) To lead the organization
- e) To instruct the Secretary to convene meetings as required
- f) To instruct other officers and members to undertake activities.
- g) To verify documents.
- h) Allowing programs to be held in various locations depending on the nature of the spinal cord disability area.

2. Functions, Duties and Powers of the Vice-Chairperson

- a) To handle all the duties of the Chairman in his absence.
- b) To work as per the directions of the Chairman.

3. Functions, duties and powers of the Secretary

- a) To supervise and operate the secretariat of the organization.
- b) To convene meetings and assemblies as directed by the chairman.
- c) To keep the documents safe.
- d) To perform other duties assigned by the chairman

4. Functions, duties and powers of the Treasurer

- a. To supervise and manage the funds of the organization
- b. To present the annual program and budget in the general assembly
- c. To maintain accounts updated.
- d. Have annual audits conducted regularly

6. Functions, Powers and Duties of the members.

- a. Actively participate in committee meetings
- b. Play a constructive role in the work of the organization.

18. Quorum

- a. General Assembly shall not be held without the presence of 65% of the total number of members.
- b. However, it shall not be deemed to conduct the assembly, if there is 51 percent of the total number of members in the reconvened general meeting as mentioned in the section 11(5) of the Statute, there shall be no obstacle in holding the meeting.

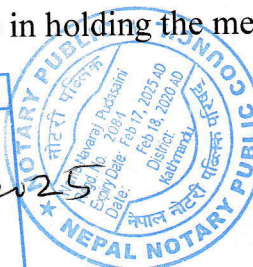

Chapter-6

Financial Provisions

19. Organizational Fund

1. There shall be a separate fund of the organization and the fund will be received under the following headings.
 - a. Amount of entrance fee and membership fee received for membership
 - b. Amount received as a voluntary donation, assistance
 - c. Amount received as a grant from a foreign organization, individual or international organization, amount received as a grant or assistance from a local body
 - d. Amount received as a grant or assistance from a local body
 - e. Amount received from a donor agency of the Government of Nepal
2. If the organization receives financial support and grants from foreign organizations or individuals, it will have to obtain approval from the Ministry of Finance and the Social Welfare Council, Government of Nepal.
3. The amount received by the organization shall be deposited in a local bank and a bank account shall be operated.

20. Bank Account

The bank account of the organization shall be operated with the joint signature of the chairman and vice-chairman. Arrangements shall be made to spend and keep a record of expenses in accordance with the prevailing laws and regulations.

21. Mode of Expenditure of funds

The amount accumulated in the fund of the organization shall be spent in the following manner.

- a) No amount may be spent from the fund without the approval of the annual budget, plan and program of the organization.
- b) The amount may be spent from the fund subject to the budget plan and program approved by the general meeting.
- c) A financial report of the amount spent from the fund shall be submitted to the general meeting compulsorily.
- d) The amount of the fund shall be spent as prescribed.

22. Accounts and Auditing of the Organization

- a) The account of income and expenditure of the organization shall be kept in a clear manner according to the prevailing law.
- b) The audit of the organization will be done by a registered auditor according to the prevailing law.
- c) The Government of Nepal or the local authorities can, at any time, depute themselves or their subordinates to check the accounts of the organization.
- d) The auditor shall be appointed by the general assembly. However, the auditor shall be appointed by the Executive Committee, until the first annual general assembly is held.
- e) Each copy of audit report and annual work progress statement of the organization shall be submitted to the local authorities, district coordination committee, social welfare council and related agencies.

Chapter-7

Provisions related to Elections, Vote of no-confidence and Statute amendments

23. Provisions relating to Elections

1. For the purpose of the election of the Working Committee, an Election Committee of a maximum of 5 members shall be formed with the consent of the Working Committee.
2. The Election Committee shall organize the election procedure itself within the scope of the prevailing law.
3. In the event of a dispute arising regarding the election, the decision of the Election Committee shall be final.
4. The Election Committee shall automatically dissolve on the day after the election is concluded.

24. Eligibility to be a candidate

One must meet the following qualifications to be a candidate for the Working Committee:

1. Have obtained Nepali citizenship
2. Have not lost mental balance





3. Have behaved within the law
4. Can read and write
5. Have not embezzled public property
6. Have not been accused of moral turpitude or corruption
7. Have completed at least 1 year of membership in this organization for the purpose of running for the Working Committee.

25. Motion of no-Confidence

1. The motion of no-confidence should be registered in writing in the following manner clearly indicating the officials against whom it is intended.
 - a. It must be written in Nepali using polite language.
 - b. The contents of the resolution should be clear and practical.
 - c. At least one-fourth members from amongst the general assembly members of the Executive Committee shall clearly sign with clear names, surnames and addresses.
2. A notice of the general assembly or the special general assembly, indicating inter alia the venue, time and date of the general assembly or special general assembly and clearly setting out the contents of the vote registered with the organization pursuant to the clause 1 has to be given to each official and members of the general assembly of the organization in accordance with section 11(4) of the statute.
3. **The procedures for discussion on the motion of no-confidence**
 - a. The person presiding over the general assembly shall give permission to submit the vote of no-confidence as referred to in sub-section (1) to the general assembly. One of the members out of the members to submit the vote of no-confidence resolution shall present his/her opinions along with the reasons for moving the vote of no-confidence.
 - b. After the members who are in favour of vote of no-confidence as referred to in sub-section 3(a) have expressed their opinions, the Chairperson may allow a maximum of other three members intending to express their opinions on the vote.

- c. The chairperson shall give the permission to the officials against whom the vote has been moved pursuant to the sub-section (1) in order to present his/her statement in his/her defence.

4. Decision on the motion of no-confidence

1. After the completion of the expression of opinions on the vote of no-confidence, the Chairperson shall, for the decision whether there is a majority in favour or against the vote of no-confidence, put the vote of no-confidence for decision in accordance with any of the following methods.
 - a. Setting those aside who vote in favour of or against the vote of no-confidence.
 - b. Sending the members of the general assembly to vote for or against the vote of no-confidence through the secret ballot.
2. For a vote of no-confidence to be adopted, it has to be resolved by a two-third majority of the total number of the general assembly members, where such a vote is so adopted, the person against whom is so adopted shall relieve of office.
3. A vote of no-confidence cannot be moved against the same person until a period of six months has expired after the failure of the vote of no-confidence or six months from the period of elected.

26. Amendment to the Statute

Only when a proposal on amendment to or repeal of any section of the statute is accepted by two-third of the total number of general assembly members, a recommendation has to be made to the Local Authority for such amendment or repeal. Any section of the statute shall be considered amended or repealed only after it is approved by the Local Authority.

27. Powers to frame rules

- a. The Organization may frame necessary rules in the course of discharging its business and such rules shall come into effect after being accepted by the general assembly and it may be notified to the local authority.
- b. Subject to this statute and the rules, rules as framed hereunder, the Executive Committee, may for the operation of business and implementation of the objectives of the organization frame and enforce rules on employees and

enforce rules on financial administration. Such rules and regulations have to be got endorsed by the general assembly.

28. Provisions relating to employee

- a. The provisions on the creation of position of employees required for the operation of the day-to-day activities, plans and programmes of the organization, remuneration, allowances and other facilities and terms and conditions of the service of the employees and the procedures required to be followed shall be as prescribed.
- b. Where the organization receives foreign assistance and it thus to hire or employ foreign consultant or volunteer for the implementation of its activities, a prior approval from the Social Welfare Council must get, a description inter alia the tenure, term of references service and rationale thereof, facilities and qualification of such consultant or volunteer shall also be forwarded to the Local Authority, the District Development Committee and the Social Welfare Council.

29. Dissolution of the Organization

- a. If 75 percent of the general meeting deems it necessary, the organization may be dissolved by passing a special resolution.
- b. While passing the resolution for the dissolution of the organization pursuant to Sub-section 1, the general meeting may appoint one or more liquidators for the purpose of dissolution and one or more auditors to conduct the accounts of the organization.
- c. The remuneration of the liquidators and auditors appointed pursuant to Sub-section 2 shall be as prescribed by the general meeting.
- d. If the organization is dissolved and dissolved for any reason, all the assets remaining after settling the liabilities of the organization shall belong to the Government of Nepal.

30. Interpretation

The Executive Committee shall have the power to interpret this statute and bye-laws framed here under.

31. Provision of divulgence of secrecy





No official or member of this organization shall act against the interest of the organization. No official or member of the General Assembly shall use indecent and vulgar words at the meeting or the General Assembly.

32. Act of prevailing

Any matters not contained in this statute shall be governed by law and if any matters stated herein is inconsistent with the organization Registration Act, rules and prevailing law, such matter, shall ipso facto, be effective to the extent of such inconsistency.

33. Abiding by the laws

It shall be the duty of the organization to be abided by the directives given by the Government of Nepal and the Local Authority from time to time.

34. Ad-hoc Committee

- The *ad-hoc* committee formed to establish and register this organization will convene a general meeting within 6 months, form an election committee as per the statute, and hold elections for a new working committee, and the local authority will be informed of this.
- Until the first election is held, the activities of the working committee shall be deemed to have been carried out under this statute.
